The Budget & Finance Committee met on Monday, May 6, 2019. The meeting was called to order.

Present at the meeting were Patty Staley, Chair, Ron Duckson, Vice Chair, Nicholas Schumacher, Secretary, Isaiah Ashba, Treasurer, Norm Neubauer, Debbie Watts and Reverend Wirrig.

Minutes for the April meetings were reviewed and approved with minor corrections notated.

Isaiah Ashba started presenting the Treasurer's reports for March and April. For the March Report, Giving was less than last year by \$218 and Year-to-date by \$9,318 (this is and will continue to be due to a large contribution that was made in 2018) but looking at prior years, we are tracking ahead. Expenses were kept pretty minimal with the primary expenses being the salaries and related expenses and utilities. Committee spending was just Building and Property for maintenance supplies. The \$1,000 contribution to cover the purchase of the chairs for the Chapel was noted on this report as was the sale of \$20,000 to cover operating expenses for the quarter. The deficit for the month is better and we continue to work on this issue. A question was raised concerning the balances in the Percy Jones (Stivers) Fund – this will be rechecked to make sure all funds have been properly entered. The checking balance is at \$23, 880.06 which includes the funds from the sale of assets to cover expenses for the quarter (hopefully longer).

For the April Report, Giving for the month is less than last year by \$432 and year to date by \$8,750. Operating expenses included salaries and related costs, utilities and approximately \$2,500 in Committee expenditures which includes approximately \$850 for the Organ Tuning for Easter, maintenance and supplies, \$450 for Guest Musicians for the month, as well as \$218 for airfare (booked now give much more discounted rates) for attendance General Synod in Wisconsin in November. It was noted that the Church Windows software is difficult and doing qwerky things which is making it difficult for the Treasurer's report. We are looking into how it can be fixed and/or hopefully eventually replaced with something more compatible to our needs.

Reverend Wirrig addressed the Committee with information from his recent SONKA Meeting specifically in the areas of the Church's financial operations. Much of what he brought to the Committee falls in line with our working towards better financial accountability, including a recent purchase of the 2018 General Accepted Accounting Procedures Handbook (GAAP). The Church needs to move from its current methodology of accounting to a more structured business accounting including better tracking and data management, more security for accounting records, bookkeeping versus money handling, better compliance with IRS guidelines for Churches and 501(c)(3) entities including annual issuance of 1099's and other tax requirements. This was made more of a concern as a requirement of the loan application was for current financial account statements. It was necessary to have an outside accountant assist with putting together financial statements that could be submitted. These were not official audited financial statements which will become necessary as we apply for various grants and funds in future. A positive from SONKA is that for purposes of local grants and private funds we can use the UCC 501(c)(3) tax id for applications, but only for local and private funds. However, we will continue to work on the Form 1023 as having our own Tax ID certified as a 501(c)(3) electronically will allow us to apply for federal monies and tax credits/grants. There have been changes to employees reporting, withholding options, housing allocations and how these items are or can be handled which will be reviewed by the Committee as we work on the budget for 2020. Parking was detailed in that all funds no matter how collected must be reported as Unrelated Business Income and is taxed currently at a 21% tax rate. Patty is however looking into a possible loophole with the fact that we are not operating the lots for income but ABM is and giving funds to the Church after their costs and percentage. The reasoning from the UCC and IRS is that if we are getting income from the lots we are in direct competition with for profit businesses/lots therefore we must be taxed on those funds as are the for profit lots.

In Old Business, Parking is moving along our first funds should be coming in soon but we need to remember that the first month was a learning month for people using our lots as well as management fee coming off before our percentage. Grants & Fundraising, ADA Compliance/Accessibility and related business will now be able to looked at again utilizing local and private grant possibilities with the availability of the UCC Tax Id until we receive our approval on our Form 1023.

In New Business: Stewardship was discussed and the campaign focus will be to try to incorporate all the growing immediate needs of the Church including the incorporation of the construction loan and other giving needs not limited to funds but time and talent needs as well.

The card reader is in and WiFi has been upgraded to include the entire first floor in preparation for this. We will be acquiring a tablet to function with the card reader and setting up the

location for the kiosk. Nick and Isaiah will be working together to get the software and accounting set up for the Website and card reader station/kiosk.

There being no further business, the meeting was adjourned.

Leaning Spire on West Tower

The spire on top of the west tower (the shorter of the two) is leaning and needs repaired. It is the one on the north east side of that tower. We are in contact with company to have repaired.

A SPIRE is a tapering structure on top of a building/tower (typically a church). It has no structural purpose. It could serve as a lightening rod. "In its mature Gothic development, the spire was an elongated, slender form that was a spectacular visual culmination of the building as well as a symbol of the heavenly aspirations of the pious people in the building." — Encyclopaedia Britannica

Church Exterior Painting

There is a contract in place between CertaPro Painters and St. John's. Originally, painting was to begin on April 22. The Painters notified the Church that it was unable to gather a crew to begin painting. The problem is the height of the bell tower and the lack of experienced aerial painters with this company. We have a relationship with CertaPro developed and B&P feel comfortable that the project will be completed satisfactorily. The project will be complete this summer.

Other Repair and Renovation Work Scheduled

Roof repairs are completed. Sturgill Roofing has completed work. There is no evidence of further interior water damage. We have experienced several rain storms to test the repairs.

Midwest Maintenance (exterior brick work) and Korrect Plumbing (furnace renovation) are waiting for the word to go with the Church. We are anticipating contracts to be signed and work scheduled this month.

Specifications are being developed to request estimates for interior repairs. The plan is to have information out to potential companies by end of July.

Chapel Renovation Complete and being used.

The Chapel is finished thanks to the time, effort and support of many members and friends. Lightening has been improved to LED bulbs and more will be replaced over time. The Chapel is currently being used for worship and meetings.

<u>Dishwasher - Part of a Bigger Project - Creation Justice</u>

B&P will meet with Women's of St. John's (WOSJ) before end of summer to discuss a proposal to move to a "Green" church and improved carbon foot print. A major part of the initiative was reusable service ware and dishes. Attempting to reduce the amount of non-recyclable usage would immediately impact the church's environmental impact. Thus, discussions about replacing the dishwasher.

Council Minutes St. John's United Church of Christ May 9, 2019

Present: Adam Wirrig, Douglas Goudy, Ballard Yates, Patty Staley, Bill Smith, Karen Clark, and Pat Kern.

Guest(s): Norm Neubauer

The meeting was called to order by President Douglas Goudy at 06:09 p.m.

Devotions: Bill Smith presented the opening devotions and prayer.

<u>Secretary's Report:</u> Ballard Yates had e-mailed and distributed the minutes of the regular council meeting of April 11, 2019. As there were no additions or corrections requested for the April minutes he asked they be approved. President Doug Goudy declared them approved.

<u>Financial and Treasurer's Report:</u> The Treasurer's report for April, 2019 had been distributed in the normal fashion to council members prior to today's meeting. In the absence of Isaiah Ashba, Patty Staley, chair of the Budget & Finance Committee made the following comments:

- Total General Offerings for April, 2019 were \$9,985 which is less than April, 2018 by \$432, and less then April, 2018 by \$8,750. The year to date number, while accurate, is misleading for analysis purposes as there was an unusually large gift made during February, 2018.
- Operating expenses included salaries and related costs, utilities and approximately \$2,500 in committee expenses.
- Primary committee expense included \$850 for organ tuning (Easter season), maintenance supplies, and \$450 for guest musicians.
- She spoke of the fact that the church was considering moving to different accounting software. We think we may be able to find a package(s) that would better fit our requirements and be easier to use. In view of our loan application efforts it has become apparent that we will need to expand some of our reporting in order to provide more detailed statements. We also need to increase our compliance with I.R.S. requirements using Generally Accepted Accounting Principles.
- An added benefit would be to acquire a cloud based system which would make the system available to our Treasurer off site from the church location. In this way he would be able to work on church reporting while not being required to physically come to our church building.
- She reported that St. John's can use the UCC 501 (c) (3) tax ID but only for local and private funds, but that we will continue to work on our own number in order to apply for any federal funding or tax credits.

Ballard Yates made a motion to approve the treasurer's report which was seconded by Karen Clark and approved by vote of the council.

Old Business

Building of Committees

This item will be an ongoing monthly item. Chris van Breukelen, who was unable to attend tonight, submitted a report on the status of nominations for officers and various team chairs to be updated by Rev. Adam Wirrig and Doug Goudy. The following have agreed to serve if nominated and elected.

Officers: President- Doug Goudy; Vice President- Chris van Breukelen; Treasurer- Isaiah Ashba.

Council Members:

External Ministry- Ethel Burns; Building-Bill Smith; Grounds-Marlene Miller; Finance-either Nathan Compton, or Patty Staley; Funding-either Nathan Compton or Patty Staley.

There have been suggestions of names for the other positions, but these people have yet to decide, or have not as of this date, been contacted.

Rev. Adam Wirrig indicated that he hoped to have a leaders meeting in early June, and perhaps to hold the ministry fair on June 30th.

New Business

Parking Update

Rev. Adam reported that our lots are being used and that he anticipates usage will increase as the Webster Station activity continues to increase and demand for parking continues to grow. There have not been any serious problems to date.

Office door knob/lock

In an effort to increase security, Doug Goudy reported that the lock to the office door had been changed. New keys have been issued to those requiring access. Records are now being kept of keys that have been issued. Over the years there have been so many keys issued, that our church was not sure who had access to the church office. Any member requiring access should contact Rev. Adam Wirrig or himself.

Finance, doing right/doing wrong, what needs to be done?

This was discussed as part of the Treasurer's Report which as presented by Patty Staley and under Items for the Good of the Order.

Adam's e-mail of May 8th

A copy is included as a part of the minutes as it was included in the agenda. The majority of the email comprised updated information. The council, by consensus, approved the Dare 2 Defy production request.

Cornerstone Update

Doug Goudy indicated that there were errors in the first part of the 2019 St. John's Directory. He has made corrections and reprinted the sheets as necessary. These will be available at the entry to the sanctuary. Items for the Good of the Order:

There was further discussion concerning necessary financial accounting changes. Among them are the following:

The requirement to have an outside independent audit of our accounting system at least once a year. Most funding resources demand such an audit.

How do we secure our information?

Acquisition of our own 501 (c) (3) tax I.D. number.

Insurance Issues.

Bonding of Officers, and a Hold Harmless clause of officers when acting in Good Faith.

Tax Liability for parking lot income. The only possible exemption would be to demonstrate that ABM operates the lots, and make contributions to the church. It is unknown whether this approach would be legal and acceptable.

Issuance and reporting of 1099 tax information statements.

Bill Smith inquired whether we need to establish a special council meeting to grant approval for the appropriate officers to sign the contracts for the deferred maintenance items after we receive the loan funding. It was decided that this was not necessary as there was full disclosure at the congregational meeting to authorize the loan application. As this process was approved the church officers were given authority to proceed with the plan.

<u>Adjournment</u>

Patty Staley made a motion that the meeting be adjourned which was seconded by Rev. Adam Wirrig and approved by vote of the council.

Closing:

The meeting was closed with all praying the Lord's Prayer.
